How to Apply

To apply for the full-time IEPP program** for the first time or for returning students:

- 1. Submit written application and necessary documents for admission
- 2. IMPAC reviews student's application
- 3. IMPAC admits student into IEPP, a full course of study
- 4. IMPAC creates SEVIS I-20 record
- 5. Student receives I-20 and acceptance letter
- 6. Student pays SEVIS I-901 fee
- 7. Student applies for Student (F-1) Visa at the American Embassy or applies for a Change of Status (COS) with United States Citizenship and Immigration Services (in case of COS, skip #8)
- 8. Student admitted into the United States in F-1 status.
- 9. Student reports to IMPAC on orientation day
- 10. Student begins classes


- 1. IECP Program follows the IEPP schedule. IECP applicants may start classes anytime, excluding the exam week, term break and the last week of the term.
- 2. Call or e-mail to make a reservation for a placement test/interview. All applicants must take a placement test and interview.
- 3. Submit a completed application and pay tuition on the placement/interview day.

Classes at IMPAC are offered on a 12-week

term schedule. The academic course schedule is 11 weeks. The 12th week is reserved for professional development for Instructors and other administrative tasks.

A one-week break follows each quarter for both the Intensive English Proficiency Program (IEPP) and the Intensive English Conversation Program (IECP). There are no classes offered during the last week of each term.






